## EUROPEAN

Religion shapes people's identities and influences relationships. Contrary to traditional European self-understanding, Europe is multi-religious. People of different faiths and cultures have to work out ways of overcoming historical animosity and find ways of living together peacefully and constructively in the context of Europe's secular societies.

## PROCESS ORIENTED

EPIL offers a unique process of learning through a carefully structured combination of learning methods, comprising academic input, live encounters with people and communities, training in intercultural and interreligious learning, and participation in religious and spiritual life. In this process the learning experiences are continuously linked to real-life situations.



## NNOVATIVE

EPIL is innovative:

- It focuses on women as major agents for developing a culture of peace in everyday life
- It focuses on Christian-Muslim relations, an area of potential conflict in European societies
- It focuses on persons who in their private and professional lives, are engaged in interreligious issues and interaction (social workers, media workers, civil servants, church/ mosque workers, NGOs, etc.)

## LONG-TERM LEARNING

The Roaming College 2015 - 2017

EPIL's new two year intensive study course is organized in the form of roaming college. Its four modules take students to four cities in four countries, where particular problems arise and where people are searching for creative responses. In between the international modules, there are activities within the country-based learning group to follow up on the learning experiences and to help embed the learning process into daily life. These activities comprise meetings between modules, particularly a three-day meeting for the national module in the various countries, and individual project work by EPIL participants.
